Planning and Preparation at Yellowhead in Early 2026

Early 2026 has been focused on planning and preparation for the Yellowhead Project Team. As the Project advances toward the next stage of the BC Environmental Assessment process, the Yellowhead team has prioritized the Detailed Project Description (DPD), which is anticipated to be submitted mid-year.

A Detailed Project Description is a comprehensive document that outlines a proposed project’s design, activities and potential effects, submitted to regulators to support the Environmental Assessment Process. The purpose of the DPD is to provide information to support the EAO readiness decision and advance the Project to the process planning phase of the provincial Environmental Assessment (EA) process.

Alongside this important milestone, the team has been actively preparing for the upcoming 2026 Site Investigation Program, continuing environmental baseline studies, engaging with local communities, and participating in career fairs across the region. These efforts reflect our commitment to thoughtful planning, collaboration, and transparency as the project progresses.

In this edition of the newsletter, you’ll find updates on these activities and learn more about what’s ahead for the Yellowhead Project.

We invite you to explore the updates in this newsletter and to stay connected as the Yellowhead Project continues to take shape. Thank you for being part of the journey.

At Taseko Yellowhead we are celebrating with a mining-knowledge contest. Set yourself up to win by following this

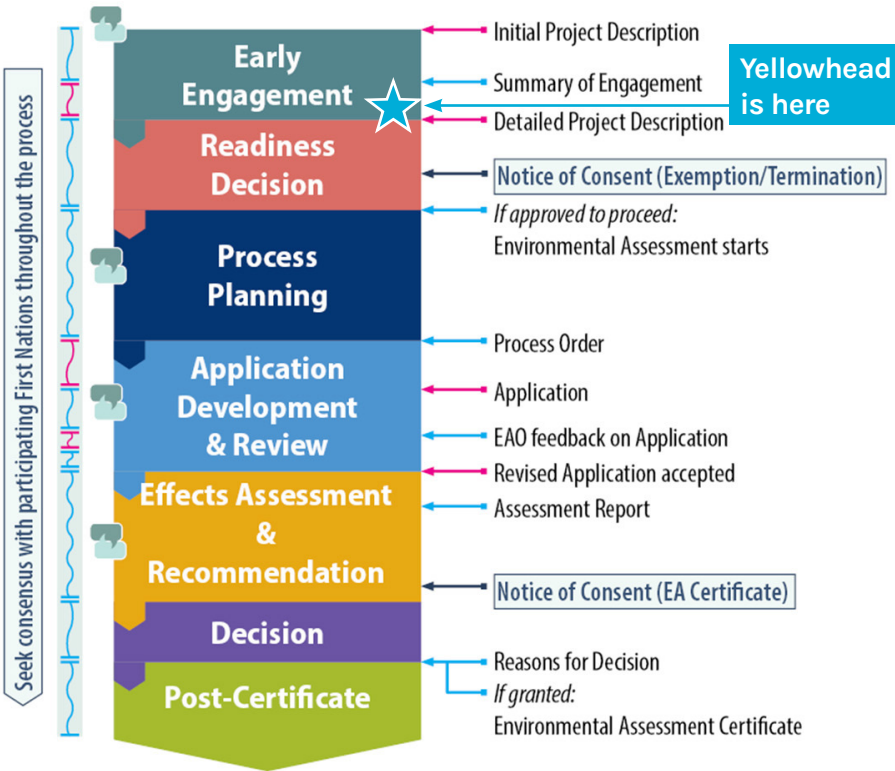

Environmental Assessment Process

The Yellowhead Project has entered the Simpcw Assessment and BC Environmental Assessment processes. The Province and Simpcw First Nation have started negotiations on a consent decision-making agreement for co-ordinated and efficient assessment of the proposed Project in Simpcw territory.

Environmental Assessment Process



The BC Environmental Assessment (EA) process is managed by the BC Environmental Assessment Office (BC EAO). The EA process evaluates the potential effects of major projects on environmental, social, economic, health and heritage values. There are a number of steps in the BC EA process that allow for a detailed evaluation of the Project and include opportunities for public input. Upon completion of the EA process, a decision is made on whether the Project should proceed. An EA certificate is required for permitting decisions to be made for the project construction and operations.

Next Step in the Early Engagement Phase

The Initial Project Description (IPD) for the Yellowhead Project was submitted in June 2025 to begin the Early Engagement phase of the BC EA process. Feedback received during the Early Engagement phase supports information gathering on what is important to First Nations, government and the public in relation to the Project assessment. The feedback from the IPD engagement also informs development of the Detailed Project Description (DPD).

The next step in the Early Engagement phase is to submit the Detailed Project Description to the BC EAO. The DPD will be used to advance the Readiness Decision phase, which determines whether the project is ready to enter into the EA process. This step is followed by the Process Planning phase which defines how the assessment will be undertaken, including confirmation of the application information requirements for the assessment. The Process Planning phase includes a public engagement and comment period.

Yellowhead Presents at Thompson Rivers University Law Student Conference

Korah De Walt-Gagnon, Yellowhead’s Project Manager, participated in the 2026 TRU Society of Law Students Conference on Mining and Critical Minerals, held on February 26 at Thompson Rivers University. The student-led conference brought together legal professionals, industry representatives, and students to explore key regulatory, environmental, and operational considerations shaping the minerals and metals sector.

The event featured thoughtful and practical discussions on project permitting, environmental compliance, Indigenous relations, and health and safety, grounded in real-world experience from across the legal and mining professions. Korah noted, “I was especially grateful for the opportunity to be part of an all female panel and to take part in conversations that reflect the depth of expertise women bring to this sector. Events like this remind me how much talent, leadership, and innovation there is in our industry, and how important it is to create space for these voices.”

Taseko's Yellowhead Project is located in the Thompson-Nicola region of British Columbia, approximately 150 km northeast of Kamloops near Vavenby, and is primarily within SimpCWúlecw, the territory of SimpCW. The proposed open-pit copper mine is designed to produce 90,000 tonnes of ore per day over a 25-year mine life, using existing road access and a nearby rail load-out facility, with a new transmission line required to supply power.
